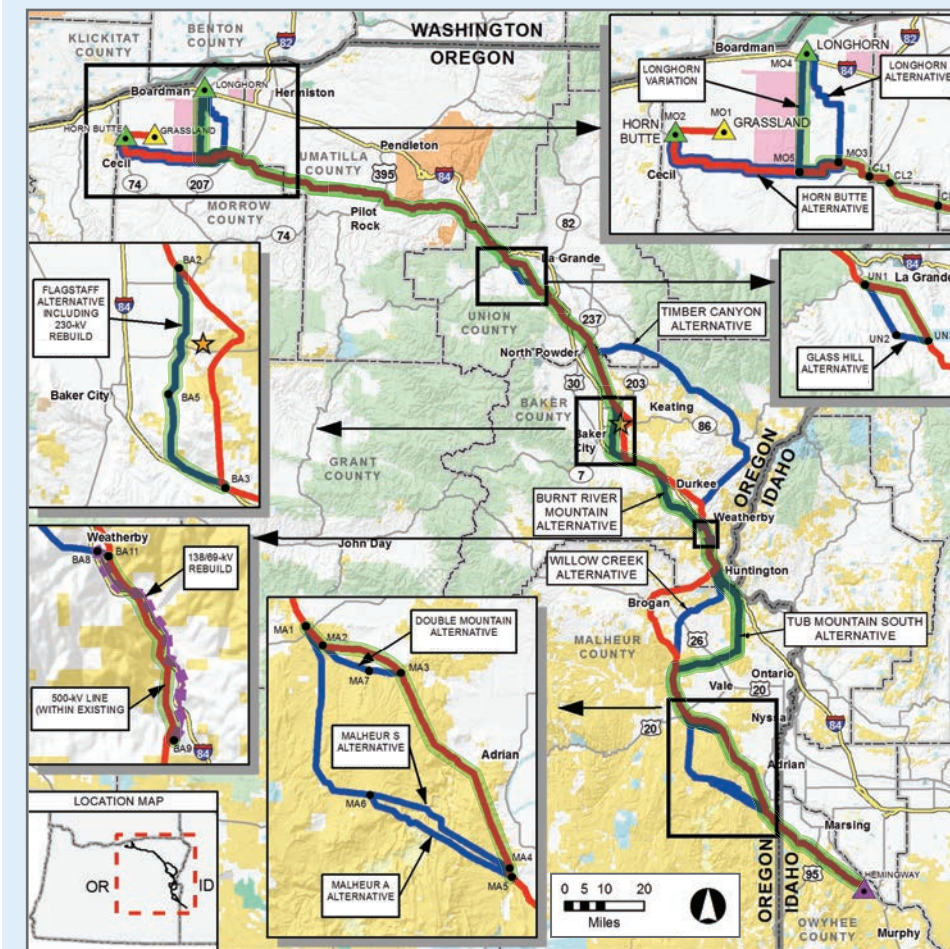


### Draft Environmental Impact Statement Released

The U.S. Bureau of Land Management (BLM) has released the Draft Environmental Impact Statement (DEIS) for the Boardman to Hemingway Transmission Line Project (B2H). The project, proposed by Idaho Power, would add approximately 300 miles of new high-voltage transmission line across northeast Oregon and southwest Idaho and rebuild five miles of existing 138 kV and 69 kV lines.

The release of the DEIS marks an important milestone in the project's environmental review process. The DEIS documents the potential effects of the Proposed Action and alternatives, including a no-action alternative. Comments on the DEIS will be accepted from December 19, 2014 through March 19, 2015. Substantive comments received during this 90-day comment period will be documented in the Final Environmental Impact Statement.

## About the project

B2H is a proposal to design, construct, operate and maintain a new 500 kilovolt, single-circuit electric transmission line from a proposed substation near Boardman, Oregon to the Hemingway Substation near Melba, Idaho. The Proposed Action would also include rebuilding a five-mile stretch of existing 138 kV and 69 kV lines.

Idaho Power has submitted applications to the BLM, U.S. Forest Service (USFS), and the Bureau of Reclamation to obtain authorization for B2H to cross the lands they manage. These agencies are obligated to review and make decisions on Idaho Power's applications.

## What is a DEIS?

Environmental impact statements are prepared under the National Environmental Policy Act (NEPA) for federal actions that may significantly affect the human environment. Authorizing a high-voltage electric transmission line on federal lands is a major federal action and a significant portion of the proposed route traverses lands managed by the BLM, USFS, and the Bureau of Reclamation.

The DEIS provides the public an opportunity to learn about and be involved in the federal decision making process by providing comments and feedback before the Final Environmental Impact Statement, which serves as the basis for the project's Record of Decision.

## Navigating the DEIS

The B2H DEIS is approximately 3,000 pages with six chapters and eight appendices. While the BLM encourages full review of the document, some key sections are highlighted below.

<p><b>Executive Summary:</b> Provides a stand-alone summary of why the DEIS has been prepared, descriptions of the Proposed Action and alternatives, and documents the potential effects of the Proposed Action.</p>	<p><b>Chapter 1, Purpose and Need:</b> Details the purpose and need for this project from Idaho Power's perspective, as well as the purpose and need for the federal environmental review.</p>	<p><b>Chapter 2, Alternatives:</b> Provides a detailed overview and summary of the proposed project, route alternatives, design variations, and the no-action alternative. Chapter 2 also summarizes the comparison between route alternatives, mitigation measures, and the necessary plan amendments.</p>	<p><b>Chapter 3, Affected Environment and Environmental Effects:</b> Describes how various components of the environment, including wildlife, historic trails and private property, would be affected by the Proposed Action and alternatives.</p>	<p><b>Appendix A:</b> Maps of the Proposed Action and alternative routes.</p>	<p><b>Appendix C, Environmental Protection Plans and Measures:</b> Includes the environmental protection measures proposed by Idaho Power.</p>

The Proposed Action and alternatives were initially presented to the public during public scoping in 2010. ## Commenting on the DEIS

All comments submitted will be read and reviewed, but only substantive comments will be fully analyzed and utilized for preparation of the final EIS. Comments are most useful that provide relevant and new information with sufficient detail. Individual response letters will not be provided. To ensure your comments are as substantive as possible, please follow one or more of these guidelines:

- Comments should:
  - Be as specific as possible. It is also helpful if comments refer to chapters, pages and line numbers of the DEIS (e.g., Chapter 1, page 1-3, line 10) along with any sources that support each comment.
  - Provide new information pertaining to the proposed project (also called “Proposed Action”), an alternative or the analysis.
  - Identify another alternative that reduces resource impacts and meets the underlying project need.
  - Identify a specific flaw in the analysis or make factual corrections, providing sources that support the correction.
  - Suggest alternate methodologies that should be used (including reasons why).
  - Identify a different source of credible research, which if used in the analysis, could result in different effects.
- Please note the Agency Preferred alternative may not be the final decision and comments provided on each alternative remain applicable. Additionally, comments that identify a new proposed alternative should indicate how it would avoid, reduce, or mitigate resource impacts better than the alternatives studied in the DEIS.
- Potentially affected landowners should review Chapter 3: Affected Environment and Environmental Consequences of the DEIS, including the associated maps found in the Appendix A.
